The conference participants are kindly asked to stay the whole length of the conference and take part in all official events (opening, plenary sessions, workshops, and closing). The participation in the cultural framework program is optional and voluntary. We invite you to actively take part through keynote presentations, in the discussions in the workshops and in the plenary sessions. At this stage we are only surveying the interest of participants in keynote presentations. In regard to the time limitations of the conference we would ask you to understand that it will not be possible for all experts to give a presentation. The conference's languages are German and English. Translation services will be provided.

On request, we offer to cover the expenses for traveling (up to a certain limit) and accommodation for participants from outside Graz as well as for our international guests. If you have the possibility to contribute by taking on some costs through your organization, we would kindly ask you to inform us. Hotel rooms in the upper mid-range are already reserved for our guests. All travel are booked by the AAI as organizer. We kindly ask you to inform us on efficient and cost-effective ways and modes of travel. Any needed travel visa has to be applied for by the participant at the locally competent Austrian representation authority (embassy). The participants will be reimbursed payable charges and fees concerning the visa application on presentation of payment receipts.

The participants in the conference are adequately medically insured-, including accident insurance - during the time of their stay in Graz.

A cancellation of participation is possible only in the event of sudden and unexpected grave illness, whereby the incapacity to travel must be confirmed by a medical doctor and has to be reported to us and the travel insurance by the participant as policyholder. In the case of cancellation for reasons not covered by the travel insurance which we buy for all participants, the participant will be charged for all occurring cancellation fees for transport and accommodation.
